Job Summary: LMCA Middle school teachers typically teach seven class periods (bells) daily - students attend eight (8) classes daily. Teachers prepare one lesson plan for up to 3 different subjects. Typically the same subject is taught to three different groups of students of the same grade level (i.e. three classes of 6th grade science). Additional duties may include lunch supervision and dismissal supervision once a week. Teachers are required to attend monthly team meetings, which take place in the afternoon (3:00 - 3:45 PM), and a monthly Bible meeting which takes place in the morning (7:00 - 7:30 AM). LMCA Middle School hosts three after-school events (Movie night, Neon night, and Water Wars). We ask middle school teachers to attend these events for connection and supervision.

Experience: Candidates must have experience in student teaching, substitute teaching, or classroom aide.
